Operations staff can easily view and prioritize these tasks via user-friendly management dashboards that provide real time risk profiles of upcoming corporate actions events and deadlines. A multi-entity structure supporting different business segments provides flexibility to decide which operational functions to perform at a local level and which to centralize, offering the benefits of cost mutualization.

#### Entitled stock record

A single view across all long and short position types consolidated from various FO/BO systems, covering book, client, trades, loans/borrows, swaps, pay to hold and depot positions. Provides for position adjustments as well as bulk/individual election entry by users and the raising of balancing exceptions

#### Counterparty deadlines, protection & liability management

Captures counterparty election deadlines and generates protection instructions / liability notices to depots and counterparties based on elections captured from clients, traders, lending desk, counterparties etc. and balanced after any arbitrage and optimization process

#### Tax and substitute payments

Supports complex tax calculations through a comprehensive tax matrix and client tax referential. Provides ability to tax based on dividend requirement rates agreed on loan and swap contracts. Also supports U.S. substitute payments / payments in lieu with gross ups

#### Claims management

Supports identification, calculation and tracking of claims against loans, trades and also sends claim notices to counterparties which can be rendered to any desired format. Also supports market auto compensation and transformation

Manages workflow and assigns tasks through dashboards that display tasks across the corporate action process to appropriate users with due dates based on the key date of an event

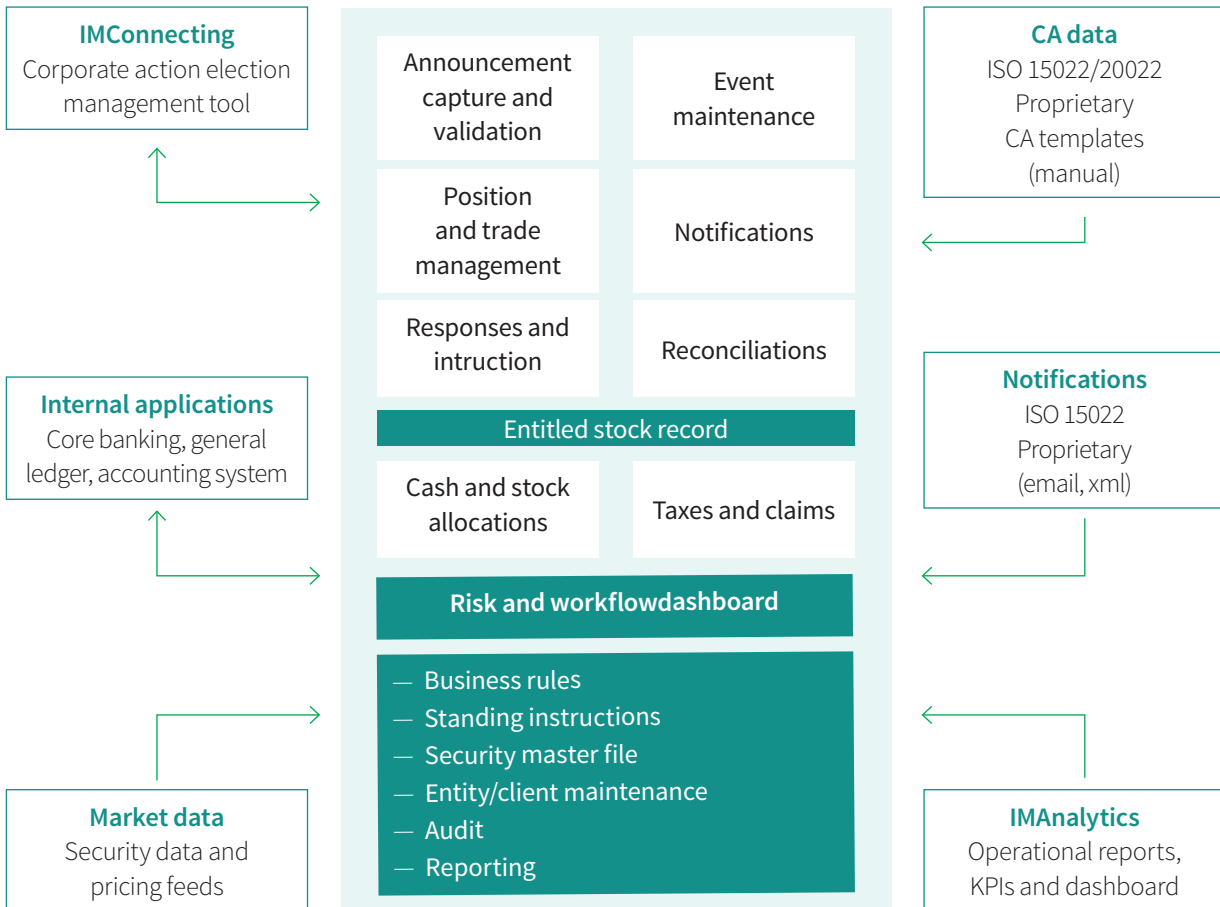
