IHS Markit Benchmark Administration Limited Consultation on changes to the constituents of the VanEck Multi-Asset Allocation Indices

LONDON, **29 JUNE**, **2022**. IHS Markit Benchmark Administration Limited (**IMBA UK**) is conducting a consultation with market participants on potential changes to the VanEck Multi-Asset Allocation Indices.

BACKGROUND AND PROPOSAL

Each index (see APPENDIX) is composed of four constituent indices. the proposal is to replace two of the constituent indices with versions that use ESG factors within their methodologies, as follows:

The objective of the proposed changes is to introduce ESG industry standards, aligned to sustainable investment strategies, before the annual rebalance of the indices takes place in September 2022.
