# IHS Markit Benchmark Administration Limited Consultation on the Cessation of iTraxx MSCI ESG Screened Europe Total and Excess Return Indices

**LONDON, NOVEMBER 18, 2022**: IHS Markit Benchmark Administration Limited (IMBA) is conducting a consultation with market participants on the proposed cessation of the iTraxx MSCI ESG Screened Europe Total and Excess Return Indices.

## BACKGROUND

The iTraxx MSCI ESG Screened Europe Total and Excess Return Indices aim to track the daily return of a long or short position in the underlying on-the-run series of the iTraxx MSCI ESG Screened Europe Index. The indices take into account coupon payments, credit events, and semi-annual roll transaction cost assumptions.

### PROPOSAL

The iTraxx MSCI ESG Screened Europe Total and Excess Return Indices use the London 5pm pricing snap (LN1700) of the iTraxx MSCI ESG Screened Europe Index as published by the S&P Market Intelligence CDS Pricing Service. Due to lack of composite pricing data on the underlying iTraxx MSCI ESG Screened Europe Index since October 17, 2022, IMBA has not been able to calculate and publish the iTraxx MSCI ESG Screened Europe Total and Excess Return Indices. Currently, days in which we are unable to publish an index level due to lack of inputs are treated as market disruption days.

In light of above and the issue of lack of adequate pricing data on the iTraxx MSCI ESG Screened Europe Index being likely to persist, IMBA proposes to cease publication of the above listed benchmarks.

### **CESSATION TIMING**

The consultation period for the above proposal ends on Friday, December 2, 2022. IMBA is proposing to cease publication of the above benchmarks one week following the end of the consultation period, i.e. on **Friday, December 9, 2022**.

- 1. Do you agree with the proposed cessation of the iTraxx MSCI ESG Screened Europe Total and Excess Return Index?
- 2. Do you agree with the proposed cessation date?

Please provide your feedback by **Friday**, **December 2**, **2022**. After this date, IMBA will no longer accept survey responses. Prior to the Index Committee's final review, IMBA may request clarifications from respondents as part of that review. In the event that no responses are received contrary to the proposal above, IMBA will implement the cessation on 9<sup>th</sup> December 2022.
